FedNor, infrastructure, and transfer payments top of mind in Northeastern Ontario for Federal Economic Agenda for Ontario

January 22, 2015, Thunder Bay, ON – The people of Northeastern Ontario say the region is being held back by a lack of federal transfer payments, innovation, workforce development, and poor engagement from FedNor. Throughout December and January, Northern Policy Institute has been collecting feedback across Northern Ontario to help build the Federal Economic Agenda for Ontario. Northern Policy Institute president and CEO, Charles Cirtwill, said that this process provides an important opportunity to shed light on the unique challenges and opportunities faced by Northern Ontario.

Northeastern Ontarians have seized that opportunity and Northern Policy Institute has received feedback from across the region, including Sudbury, Manitowaning, Magnetawan, North Bay, and Huntsville.

All feedback collected so far has listed federal transfer payments as having a significant impact on communities in the region. Respondents claim that a lack of federal transfers are inhibiting communities from developing infrastructure and holding them back in terms of innovation and education. Additionally, communities are calling for a review of FedNor in order to better align the program with the issues and priorities of Northern Ontario. There appears to be a lack of engagement from FedNor in Northeastern communities and some respondents want FedNor to take a stronger leadership role in the region.

Aboriginal education and training was also a key issue for many respondents. In Sudbury, there is a call for a stronger Aboriginal voice that can only be achieved through government dialogue. Other regions want to see more workforce development and the Aboriginal population included in the workforce through more training and education opportunities.

“It is clear that there are a lot of issues on the minds of people in Northeastern Ontario,” says Cirtwill. “We are pleased to see so many people speaking up and wanting a Northern voice included in the Federal Economic Agenda for Ontario. With many respondents seeing FedNor and federal transfers as a major issue impacting the region, it is key that these issues are included in this agenda because they are directly impacted by federal policy-makers.”

This is just a small selection of the feedback received so far. Consultations will be ongoing until January 31, 2015. The people of Northeastern Ontario are still encouraged to have their say. According to the discussion paper, the purpose of the Federal Economic Agenda for Ontario is to: “define clearly the challenges and opportunities facing Ontario, develop a common vision and agenda on key economic issues, inform public dialogue, outline policy options that could be pursued by the federal government, and inform platform development by political parties in the lead up to the federal election.”

The feedback that is collected will be used to complete the Federal Economic Agenda for Ontario with an intended release in the spring of 2015.
