This position is ideal for those seeking to build firsthand experience about real world policy research. How it is done, how it is crafted, and to whom and how it is communicated. The added benefit is a chance to expand your knowledge and understanding of Northern Ontario.

The Policy Analyst will be an active member of NPI's Community Capacity team. Roll up your sleeves and be ready to do real analysis on the challenges and opportunities of e-vehicles in rural and remote communities. Explore global experience and use those lessons to improve access and affordability of e-vehicles at home. Are range concerns overblown? How many charging centres are realistically needed? What demands might be placed on the grid?

Public administration, political science, or environment students may find this position especially rewarding. But anyone interested in green technology and its implications for rural and remote communities should apply. Join an amazing team and learn to make an evidence-based case on making good policy decisions that affect the lives of real people.

Candidates are asked to provide a one paragraph statement as to why they have applied for the position in this specific community. Applications that do not include this information may not be considered.

Northern Policy Institute appreciates all expressions of interest; **only candidates who are to be interviewed will be contacted.** The salary range for this position is \$18-\$20 per hour for Bachelor or College level candidates, and \$20-\$22 per hour for Master level candidates. Placements will begin 09 May 2022 and end 26 August 2022.

An increment of \$500 over and above base salary is available for those who can fluently speak both French and English in a professional setting.

Deadline for applications is **midnight eastern time 09 January 2022.**

Experience North receives partial funding from the Canada Summer Jobs Program. Applicants should be aware of the eligibility requirements for that program. To be eligible for Canada Summer Jobs Funding, youth must: **be a resident (temporarily or permanently) in the federal riding where the grant is disbursed**; be between 15 and 30 years of age at the start of the employment; be a **Canadian citizen, permanent resident, or person to whom refugee protection has been conferred** under the Immigration and Refugee Protection Act for the duration of the employment; and, have a valid Social Insurance Number at the start of employment and be legally entitled to work in Canada in accordance with relevant provincial or territorial legislation and regulations.

*Experience North is a program intended to build capacity in Northern Ontario. As such, while spots are not allocated to specific demographics, there is a hiring preference in place. When considering applications from two equally qualified candidates, NPI will give preference to First Nation, Métis, Inuit, or Francophone candidates. Candidates coming from rural or remote northern communities or with a stated interest in working in northern regions in the future will also be given special preference. If any of these characteristics apply to you, **we encourage you to voluntarily state this in your cover letter.***
